#### **About the eHealth Asia 2015**

The Health Informatics Society of Sri Lanka (HISSL www.hissl.lk) is the national professional association for Health Informatics Specialists in Sri Lanka. It is the only professional body in Health Informatics that functions under the Sri Lanka Medical Association (SLMA); as a professional entity.
